Michael J. Rusnak began his career as a Trial Attorney with the Internal Revenue Service District Counsel's Office (1977-82). He is an experienced litigator in representing clients before the IRS, the Indiana Department of Revenue, and the Courts in civil and criminal tax matters.

He is a past Chair of the Taxation Sections of the Indiana State Bar Association (1995-96), Indianapolis Bar Association (1988), and IRS Central Region Bar Liaison Group (1993-94). He has also served on the IRS Regional Counsel Bar Advisory Group for the IRS Central Region (1991-92).
